 - Defibrillators: Replacement Batteries and conductive Pads required. Replacements for each unit ordered bringing replacement schedule in line for ease of management. Structured control procedures to be reviewed and approved. Designated 'responsible persons' to be advised of procedures. Maintenance of records for each unit required.
