 - **Pitmedden School and Nursery Project - Communication received from** Early Years Senior Practitioner, Pitmedden School Nursery regarding UCC support for the ambitious plans for Pitmedden School Nursery to completely renovate the current nursery garden space. All UCC members copied requesting indication of support or otherwise.
 - **Pitmedden Traffic Speeding**: Evening Express contacted UCC secretary regarding planned article about Traffic Speed through Pitmedden. Subject had been picked up through social media. A request for comment made to secretary which was willingly provided. Photographer shall attend on 15th April, located at southerly entrance to Pitmedden along with reporter, Chair and secretary plus residents of Pitmedden shall attend.

- **Defibs** update on Owner / maintenance at each location. Register and guidance. (Ray Still contact details / Hattoncrook location)
- **Local Flooding (22nd October 2020)** - Notification of a local resident, Matthew Howland, has been submitted to Nick Rae of Aberdeenshire Flood Risk requesting inclusion in to the Pitmedden Water Level Gauge Flood Alarm Notifications system.
- **Community Asset transfer**. Item carried over from March meeting. Confirmation that the grassed area at Keithleigh Garden is owned by Aberdeenshire Council (Housing account). Suggested that there has been / existing proposals for this 'plot'. Consideration of UCC ownership interest to be concluded.
- **Bonnyton / Ingleside / Kirwood**: no change to situation re live application, appeal decision of 9th July 2020.
- **Village Orderly Grant commitments**: Monies due for distribution to Paths / Park outstanding. Tree Planting completed with UCA kindly carrying out the physical element. 27 trees of various Native Scottish species procured. Outlay, settlement outstanding. Completion of 'Litter Pick' outstanding, mutually suitable date to be agreed. Situation regarding completion and overdue activities confirmed with Aberdeenshire council at their request, required for budget report.
